4. PARTICIPATION DOCUMENTS

a) Drawings: 1 top view, 2 or 3 front views, 1 or 2 perspective views, 2 or 3 construction details. Scale of the drawings: 1:20, scale of the details 1:5.

The designs should be on applied display boards (thickness 5 mm) dimensions 35 cm X 50 cm

b) The electronic format with the participating designs should be in tif or eps 300 dpi form .

- c) Technical description, up to 300 words.
- d) Curriculum Vitae, (which should include the address of the candidate), up to 200 words
- e) Declaration of the candidate in which they will declare their unconditional acceptance of the competition terms. The participation documents will not be returned, after they have been submitted.

All the above certificates should be written either in Greece or in English.

The election of the three best drawings will be done during a meeting of the Valuation Committee. There will be a ceremony for the presentation of the awards and there will be an album issued with the awards, praises and participations.
