### **1. PARTICIPATION**

Every interested person has the opportunity to submit their design for one or more of the following items as well as for furniture that serve more than one of the following uses:

#### **4. PARTICIPATION DOCUMENTS**

For the participation is necessarily required by the participants to submit:

1. Drawings: A floor plan, 2 or 3 views, 1 or 2 perspectives, 2 or 3 construction details. Axonometric showing the way and stages of construction and assembly of the individual pieces that compose the proposed furniture.

Scale of drawings: 1:20, detail scale 1: 5, axonometric scale 1:50.

The works should be glued to presentation boards (5 mm thick) measurements 35 cm x50 cm. On the signboard, which should be anonymous, the title of the project and a brief technical description will be given.

2. An electronic file with the works of the contest and the presentation boards, in .tif or .eps 300dpi format.

3. Technical Description, up to 300 words (both printed and electronic) showing the title of the design (not the name of the designer).

4. Curriculum vitae, which must include the full address, telephone and mail of the competitor, up to 200 words (both printed and electronic).

5. Statutory Declaration of the participant for unconditional acceptance of the terms of the competition (it does not need to be considered by a public authority).

The language in which the above documents will be filed is Greek.

Entry documents after submission are not refunded.

## **5. EVALUATION COMMITTEE**

The Evaluation Committee is a five-member panel of representatives of industrial design, architecture and ergonomics.

## **6. EVALUATION CRITERIA FOR DESIGNS**

- Their usability in modern times
- Ergonomics
- Modern and high aesthetics
- Adaptability in workplaces
- The possibility of their industrial production with the materials and the means of modern technology
- Originality and Innovation
- The ecological character of the product

## **7. EVALUATION PROCEDURE**

After the deadline for participation, each member of the Commission will evaluate all the proposals submitted. The three best projects will be presented at a meeting of the

Evaluation Committee, on a date to be announced to the participants. A prize award ceremony will follow and an album with prizes and awards will be published.

## **8. GENERAL TERMS**

DROMEAS S.A collects the personal data communicated to it by the participants during the above procedure of participation. These data are used for the purposes of the competition.

DROMEAS SA has the right to publicly display the contest and the contestants' projects, as well as to publish the award and names, photos or other elements of the CV of the winners.

Furthermore, DROMEAS SA may keep a record of the present and previous tenders by including part of the above personal data.

DROMEAS S.A does not bear any responsibility if contestants submit designs against infringement of third party intellectual property rights.
